Kansas Four-Ball Championship	96	<b>OPEN:</b> 54 holes of four-ball stroke play. Open to all ages.  <b>MASTERS:</b> 54 holes of four-ball stroke play. Both team members must be at least 30 years old.	Open to any amateur golfer, including KGA non-members.  Refer to the KGA website for complete tournament information.  <b>Carts included for all rounds of championship.</b>
Father & Son	96	36 holes of four-ball stroke play with gross and net competition. <b>Two divisions available:</b> (Open and Junior Division). Cart included for both rounds of championship.	Open to male amateur golfers. One team member must be a KGA member, and both players must have a USGA handicap. Grandfather/grandson and step-father/step-son teams may participate. No minimum age for juniors
Senior Team Championship	96	1 <sup>st</sup> round: Two-man Shamble 2 <sup>nd</sup> round: Modified Chapman Alternate Shot 3 <sup>rd</sup> round: Four-Ball Stroke Play	Any KGA member that turns 50 years old by September 24, 2012 and has a USGA handicap.  <b>Three divisions available:</b> Championship, Net, Super Senior.
Mid-Amateur Team	96	1 <sup>st</sup> round: Two-man Shamble. 2 <sup>nd</sup> round: Modified Chapman Alternate Shot. 3 <sup>rd</sup> round: Four-Ball Stroke Play. Cart provided as part of entry fee.	Any KGA member that turns 25 years old by October 1, 2012 and has a USGA handicap. The team must have a combined Handicap Index of 16 or less.

**REFUNDS:** The KGA's policy is no refunds except for sickness or extenuating circumstances. To withdraw, please notify the KGA office immediately.

- If a player properly withdraws prior to the close of entries, upon proper written request, the player will receive a full refund of the entry fee, less a \$20 administrative fee.
- If a player properly withdraws after the entries close and more than 48 hours prior to the start of the event, upon proper written request, the player will receive a refund of 50% of the entry fee.
- NO REFUND will be made to a player that withdraws less than 48 hours prior to the start of the event.

**ENTRY PRIORITY STATUS:** Any team (team members must be the same) that entered the championship each of the preceding two years (2010 and 2011) shall have an entry priority over other earlier entrants that did not enter the event in both of those prior years. This entry priority will be given to eligible entrants from February 1 to March 1 only.
