_____ \$175.00 - Annual club dues for golf clubs or golf courses that enrolls its active golfing members (101 or more) as individual KGA members* at an annual fee as stated below. (This category includes golf clubs without real estate.)

_____ \$500.00 - Annual club dues for golf clubs or golf courses that have their handicaps computed by either the Kansas City Golf Association or other golf association. This will entitle golfers of these clubs, who are active on the GHIN service, KGA tournament eligibility.

The 2012 Individual membership dues per golfer are:

Men's 18 or 9 hole handicap - Electronic Option handicapping (via computer) - \$19.00

Ladies' 18 or 9 hole handicap - Electronic Option handicapping (via computer) - \$9.00

Junior** - Electronic or Paper Option - \$8.00

***Junior golfers are defined as golfers who have not reached their 18th birthday at the beginning of the golfing season (their birth date must be included in their Junior type golfer record). They will be automatically upgraded to regular membership following their 18th birthday.*
